## **EPOS EDUCATIONAL COMMITTEE**



EPOS Educational Committee has set up "EPOS BAT Educational Programme". The programme meets the demands required by the European Board of Orthopaedics and Traumatology (EBOT). The acronym BAT arises from Basic-, Advanced- and Traumatology Courses. These courses together constitute "EPOS BAT Educational Programme" and aim to facilitate a problem-solving approach in the diagnosis and management of orthopaedic conditions in children informed by relevant research evidence. A module of two Basic Courses in combination with one Traumatology Course covers the core curriculum in Children's Orthopaedics.

Advanced Courses are primarily designed for Children Orthopaedic Surgeons who manage children's orthopaedic conditions in a highly specialized setting. Course teaching Faculties are composed of highly internationally recognized specialists in Children's Orthopaedics from all over Europe.

### **EPOS Scholarship**

The EPOS Board wants to support the "EPOS BAT Educational Programme" by Scholarships. Hence Scholarships are launched on the EPOS Website before each trilogy of BAT-courses. The successful candidates are awarded 1500 € meant to cover partly the expenditures related to travel and accommodation. An application form will be available on the EPOS website.

### **EPOS Travelling Fellowship**

The EPOS travelling Fellowship is a program created by the Pediatric Orthopaedic Society of North America (POSNA) and EPOS. The programme offers young pediatric orthopaedic surgeons the opportunity to travel and shadow other orthopaedic surgeons abroad.

Candidates for the EPOS travelling Fellowship should meet the following requirements

- Age under 40 years
- Major interest in paediatric orthopaedics
- Scientific works related to paediatric orthopaedics
- Satisfactory knowledge in English
- · Complete training programme in orthopaedics with further experience in paediatric orthopaedics

EPOS membership is not required, the three elected fellows becoming automatically EPOS members (free of fees for one year).

# READING COMMITTEE (RC) REPORT (HALF-YEAR REPORT FOR 2012)




Dear Colleagues,

This year, for Athens EPOS 2013 Meeting, our society reached, maybe, a record number of submitted abstracts i.e. 470 in total (380 for podium/oral and 90 for posters presentations) from forty-three countries. For our members and our guests it may be important to know that «only» the best 84 (eighty-four) or approx. 17,8% of 470 abstracts, will be accepted for podium presentations. The rest of the best scored abstracts will be accepted as poster presentation. RC members finished their job by Dec. 7th. 2012., and the programme committee will work hard in the next few weeks.

Notification of abstract acceptance will be send to authors by the end of December 2012.

### Top five countires that abstracts were submitted from are:

- U.K 56 (46 for podium + 10 for posters)
- U.S 52 (48+4)
- France 47 (44+3);
- **Greece** (host county) 36 (23+13)
- Turkey 30 (19+11).



This year we have 26 members of RC from 18 countries, with five new members from Belgium (2014 EPOS meeting host country); Greece (2013 LOC chairman); Italy, Poland and Switzerland. New survey of EPOS active membership is planed for the spring 2013 with the aim to gather names of those EPOS members who are willing to help EPOS RC in the next three years. In the future years, RC should have 30 members with 1/6 of RC members to be substituted every year.

## INFORMATION FROM THE TREASURER



Our Treasurer, Thomas Wirth, reports that a good number of members have still not payed the membership fee for 2012, and some are even owing for several years. EPOS does need your continued support, also economically, to maintain our high level of activities in education, communication of science, and publication of the Journal. In relation to the publisher of The Journal of Children's Orthopaedics, Springer, it is a source of some embarrassment to us that some members receive the Journal for a period of time although the membership fee has not been payed to cover this cost.

Included among the benefits for paying members are a significant discount in the registration fee for the Congresses, access to Pre-meeting Courses, the Journal, and of course, the general well-being related to being a member in good standing in every respect! And in many countries, the membership fee will be tax deductable, always a nice feeling at that time of the year!

The Treasurer is in the process of mailing reminders to non-paying members. In the near future, we expect to be able to provide access for members to review their status of payment of the membership fee via the homepage, and also to pay the membership fee right there. It should be noted that, according to the statutes of EPOS, Article 3, Section IV: "Continuing Membership", EPOS has the right to terminate a membership if the member "fails to pay his dues for two consecutive years". This rule has not always been rigorously enforced, but we think that perhaps it should out of respect to all those who do fortunately pay in a timely manner.

# Annual Meeting of EPOS Athens, Greece, 17 - 20 April 2013



In April 2013, Athens will host the Annual Meeting of the European Paediatric Orthopaedic Society (EPOS), a congress known for the top quality of the data presented there. Prof Dr Muharrem Yazici, professor of orthopaedics at Hacettepe University in Ankara, Turkey and the current president of EPOS, stresses the valuable and active collaboration between EPOS and EFORT in research and education.


"The EPOS annual meeting is the most important convention of the paediatric orthopaedic community in the EMEA region. At EPOS, we are preparing to host members from geographic Europe and from around the world in Athens next April. For this 32nd meeting, we promise attendees the same outstanding scientific quality and warm hospitality as at the 31 meetings before plus unforgettable moments in the lovely city of Athens. Those who wish to submit abstracts for the meeting should hurry, as the deadline for submission is October 15th. Participants can contribute to the scientific side of the meeting not only with presentations but also by taking an active part in discussions," Professor Muharrem Yazici, current president of EPOS, says, adding: "Everyone intending to spend three to four days next spring taking in an extensive scientific programme on paediatric orthopaedics with impressive Southern Europe as the backdrop is invited to visit www.epos2013.gr and take advantage of the benefits of early registration".

EPOS meetings are known for the meticulous selection process that abstract submissions undergo before being accepted for presentation. "The EPOS board has never been disappointed by this process. In the last few years, new scientific formats have been included in the programme, alongside highquality oral and poster presentations. We try to offer a growing number of educational activities to enable attendees to update their paediatric orthopaedic knowledge by revisiting current concepts, especially controversial ones," explains Professor Yazici.

To Professor Yazici, an expert in paediatric orthopaedics, the close collaboration between EPOS and EFORT is of great importance and more than just a remedy against the "danger of isolation" brought about by subspecialisation: "We do not view EFORT as a competitor, but rather as a team member working for the same objective. As a platform EFORT assists us in our attempt to reach out to general orthopaedists and other subspecialty members. It is an important partner at the level of the European Union and a strong organisation, being the largest network representing European orthopaedics. We recognize that EFORT considers us a respected partner and are very pleased with this collaboration. EPOS is working diligently to prepare the best possible scientific content in EFORT's activities related to paediatric orthopaedic education. EFORT, for its part, is using its resources to ensure that a large number of practitioners can derive maximum benefit from this content. There are obvious advantages to having two organisations working for the same objective, collaborating closely and achieving synergy to reach a common goal. The leaders of EPOS and EFORT are enthusiastic and motivated about finding new areas of collaboration within this mutually agreed arrangement."

Professor Yazici cites the EPOS BAT Educational Programme as a perfect example of a joint effort between the two societies, calling it "the most solid and vivid indicator of what can be done when EFORT's organisational skills and infrastructure are combined with the motivation of a subspecialty society and the dedication of its members." The programme meets the demands required by the European Board of Orthopaedics and Traumatology (EBOT). The eponym BAT arises from Basic Courses, Advanced Courses and Traumatology Courses. EPOS is already making plans for the future of the program, including "the enriching of its content by setting up courses for residents along with those for young specialists, making resident courses compulsory for residents in Europe and using e-learning capabilities for this purpose."

Professor Yazici expects EPOS and EFORT to cross paths even more frequently in the near future: "New activities coming out of this collaboration may make use of the technological capabilities of the modern world such as webinars, synchronous and asynchronous e-education modules, electronic and printed material publications".
